 - iv. Fundraising issues and strategies discussed. A building committee and financial committee would have to be set up. Noted that property tax and serving of liquor laws varies in RI municipalities.

 - vi. The committee will develop some proforma operating budgets for some scenarios in different RI locations. Roles and expansion of responsibilities within the club discussed. This will support the process of understanding the potential for an operating dedicated club.
